We, SOUTH CHINA INSURANCE COMPANY LIMITED (hereinafter called "the company") hereby agree, in consideration of the payment to us by or on behalf of the insured of the premium as arranged, to insure against his liability arising from an accident occurring during the period of insurance to the extent and in the manner hereinafter provided.

3. PERIOD: 12 months as from December 06, 2025 12:00 to December 06, 2026 12:00

4. INTEREST:

- (I) The assured's legal & contractual liability arising from Bills of Lading issued by the assured or insured in the assured's name as a principal that would include a House Air Waybill; a House Ocean Bill of Lading; a House Ocean/Air Bill of Lading; a House Air/Ocean Bill of Lading.
- (II) Further extension to cover assureds legal & contractual liability in the following
 - (1) the assured's liability arising from a contract of carriage entered into by the assured as a carrier of goods even if a house bill of lading had not been issued by the assured but so long as a master bill of lading has been issued by the carriers agents, contractors, or actual carriers in respect of the aforementioned carriage.
 - (2) the assured's liability arising from a Bill of Lading involving co-load shipments.
 - (3) the assured's liability arising from his duties and liabilities as a carrier or goods where the assured has issued a shipping order prior to issuing a House Bill of Lading or Air Waybill of Lading.

5. TERRITORIAL LIMITS: From Worldwide to Worldwide

6. LIMIT OF LIABILITY:

- (1) NTD5,000,000 for any one B/L
- (2) NTD5,000,000 for any one accident and/or occurrence
- (3) NTD10,000,000 for aggregate liability during this policy period
- (4) NTD3,000,000 release cargo without B/L, for any one accident and/or occurrence and/or aggregate liability

- (4) Cargo's proportion of general average & salvage.
- (5) Delay in the dispatch, carriage or delivery of cargo.
- (6) Including Error and Omission.
- (7) Without production of an original Bill of Lading, Waybill or similar of carriage or delivery of cargo to an authorized or unentitled person.
- (8) Sanction Limitation and Exclusion Clause

DEDUCTIBLE:

- (1) Without production of an original BILL of LADING, WAYBILL or similar of carriage or delivery of cargo to an authorized or untitled person: NTD300,000 each and every loss
- (2) Others: 10% of loss, min. USD1,500 each and every loss.

10. CANCELLATION:

This policy may be cancelled at any time by either party giving 30 days notice in writing. The company receiving notice will receive and retain the customary short term or earned premium whichever is the greater or when giving notice receive and retain pro-rata or earned premium whichever is the greater.

Notwithstanding any clause or condition contained herein to the contrary, it is hereby understood that in the event of cancellation, the company hereon and/or their broker/representative will notify the ministry of transportation and communication of the republic of china by giving 30 days notice in writing sent by registered mail.

11. NOTICE OF CLAIMS:

In the event of a claim for which the company may be liable immediate notice must be given to the company or its branch office by the insured.

Whereas the insured named in the schedule has made to the company a proposal for the insurance hereinafter contained and has paid or agreed to pay premium as consideration for such insurance or during any period for which the company may accept payment for the renewal of this policy.

Now this policy witness that subject to the terms contained herein or endorsed hereon the company will indemnify the insured against his liability as an air and/or sea freight forwarder and/or NVOCC and/or otherwise specifically stated herein under the conditions seen and
